Welcome new appointees, Minutes Approval- Becky Kapp

Minutes were approved.

Discussion of Director Succession Plan / Reauthorization Steps – Mark Supiano

Currently the Commission on Aging Director position is currently directorless and administratorless – Commission is now us. 1) Gave a brief history of the commission and how the director position came to be controlled under the University – the original request came through the former Governor Huntsman's office to have the position moved to the University. With the current vacancy in both the director and the coordinator's we need a successor. But the successor needs to know that the position is at this moment one year – commission is operating on the budget of the 4 years 100K, not a full FTE at this moment the only funding is from the state. The position was posted on 4/20/16 and a link was sent out to all the commission members. Identified a possible candidate. Whoever is approved as the new director will have to have the approval by the Governor's Office. 2) Reauthorization Steps – mapped out a strategy to get the appropriate legislative people on board - Jason Perry has agreed to help bring a proposal forward to the legislation. The director of the Commission is going to need to be actively involved to keep the commission going. Requesting five years of support. 3) During the vacancy until filled – Heather Podolan and Holly Abel will be filling in for the time being until the admin help gets hired. Dr. Mark Supiano and Blake Rose will be happy to answer any questions that arise during the vacancy.

Age-Friendly City Efforts – Cindy Turnquist

Age- Friendly Cities is a world help organization. Currently there are over 80 cities in the US that have the age-friendly designation. To receive the designation it is a two year development process. Dr. Keith Diaz-Moore (Dean of the College of Architecture & Planning at the University of Utah) put a proposal together and it is with the Mayor's office in SLC. There is a current checklist on how to become an age friendly city. As a county, Salt Lake County will be investigating the possibility of' going forward for the age friendly city designation. There will be a unified effort between the county and the city. There will be a housing conference (May 20-21, 2016) – Aging Better Together.

Utah Advance Care Planning Summit Report – Deepthi Rajeev

The aging summit (April 4, 2016) was very well received. Went over POLST and shared best practices that encourage advance care planning conversations and promote patient/family and provider satisfaction.

Financial Fraud Committee progress report – Alan Ormsby
